#### Event Terms And Conditions

1. Delegates will have a seat held for them upon receipt of the registration form and the payment of the Event Fees.

4. After a sales contract has been received by AFOES, cancellations are subject to a 50% cancellation liability. Cancellations must be received in writing five (5) weeks before the event in order to obtain a credit for future events conducted by AFOES. Should cancellations be received within five (5) weeks of the event, the full event fees must be paid and no refund will be given.
